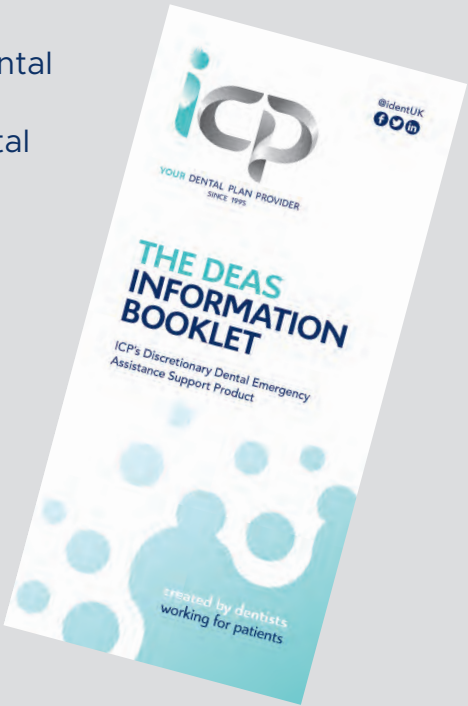


# Dental Emergency Assistance Support (DEAS) product
